

ACTIVITY REPORT

June – October 2024

1. Legislative / Parliamentary work

1.1 Bill C-20, Public Complaints and Review Commission Act

Bill C-20 would create a new, independent review agency for both the RCMP and CBSA. It would replace the current RCMP review body, and create the first ever independent review body for the CBSA. The creation of an independent review body for the CBSA has been a longstanding, key demand and advocacy priority of the ICLMG coalition.

Since the last assembly, ICLMG:

- Organized meetings with partner organizations and member groups to discuss the bill and coordinate strategy
- Sent a joint brief with colleagues including proposed amendments for the Senate committee study of the bill: <u>https://iclmg.ca/c-20-brief-senate/</u>
- On October 31, 2024, Bill C-20 received Royal Assent. ICLMG will continue to work on bringing improvements to the new review body throughout the regulation process and as the new review body is established

1.2 Bill C-27, Digital Charter Implementation Act, 2022

Bill C-27 is the government's proposed update to Canada's private sector privacy law, namely the *Personal Information Protection and Electronic Documents Act*. It will also increase powers granted to the Privacy Commissioner, create a new tribunal, and enact a new *Artificial Intelligence and Data Act* (AIDA). While our primary focus is not on the private sector, there are key aspects of this bill that have an impact on national security, surveillance and privacy rights. AIDA will have more direct repercussions on our work, given the growing use of AI in surveillance capitalism and government surveillance.

Since the last assembly, ICLMG:

- Continued to organize meetings with partner organizations and privacy experts to discuss advocacy strategy regarding the bill
- Monitored the bill's progress at committee

1.3 Bill C-41, *An Act to amend the Criminal Code and to make consequential amendments to other* <u>Acts</u>

Humanitarian aid and international assistance generally is being hindered by Canada's anti-terrorism laws, particularly in Afghanistan – a risk ICLMG has long warned about. In Spring 2023, the government tabled Bill C-41 to ostensibly address the issue through amendments to the Criminal Code. Despite several remaining shortcomings, the bill received royal assent in June 2023. The authorization regime was finally launched in June 2024; as of September 2024, no application has been approved.

Since our last assembly, ICLMG:

- Continued to participate in the informal C-41 legal working group to discuss implementation of Bill C-41 and monitor the development of regulations
- Discussed advocacy strategies to raise concerns about the implementation of the authorization regime with ICLMG members

<u>1.4 "Online harms" legislation: Bill C-63</u>

The federal government introduced Bill C-63 in February 2024. Known as the "Online Harms Act," it responds to many of our concerns with the government's original "online harms" proposal from 2021, but several aspects of the bill continue to raise serious concerns. Since our last assembly, ICLMG has:

- Continued participating in meetings of the "Online Harms Network"
- Presented at the Digital Justice Summit on Legal and Policy Solutions for Online Harms organized by NCCM and OpenMedia in September in Ottawa
- Met with NDP MP Peter Julian regarding concerns with the bill

1.5 Foreign Interference legislation: Bill C-70

Although the federal inquiry into foreign interference had yet to issue its final report, in May 2024 the federal government introduced new foreign interference legislation, Bill C-70. Much of it reflects proposals from a consultation held from December to February, but fails to respond to many of the concerns that we raised with the government. Following an extremely rushed parliamentary process, the bill was adopted in June 2024 with very little study, and minimal amendments. Since last assembly, we have:

- Thoroughly analyzed the bill and met with other Canadian & international groups to discuss concerns
- Wrote a letter to the House committee studying the bill, co-signed by several partner organizations, to urge MPs to extend the study of C-70: <u>https://iclmg.ca/joint-statement-c-70/</u>
- Appeared at both the House of Commons Public Safety committee and the Senate National Security committee to present our concerns and warn that the bill will violate Charter rights if

- Created a letter-writing campaign we updated three times in less than two weeks:
 - First, calling on Parliament to extend the study of the bill to protect rights: https://iclmg.ca/action-foreign-interference-bill/
 - Then, calling the Senate to extend the study of the bill
 - Finally, calling on the Senate to amend to bill to protect our rights

1.6 Meetings with MPs & government officials and committee appearances

The ICLMG has continued to meet with various MPs, aids and government staff about the coalition's policies and priorities, including:

- Met with Senator Yuen Pau Woo regarding Bill C-70
- Participated in NSIRA roundtable with academics and civil society
- Participated in CBSA & Digital Tools at the border roundtable consultation and follow-up
- Participated in the consultation on strengthening UN Counterterrorism Executive Directorate's civil society engagement
- Participated in the Office of the Privacy Commissioner of Canada's Civil Society roundtable
- Met with NDP House Leader Peter Julian regarding Bill C-63
- Met with Public Safety advisors regarding Bill C-20
- Meeting with Amira Elghawaby, Special Representative on Combatting Islamophobia of Canada

2. Accountability and oversight

2.1 National Security and Intelligence Review Agency

As part of its work on accountability and review, the ICLMG continues to monitor and react to the work of the NSIRA. Since the last assembly this has included following up with NSIRA for details regarding their review of the CRA's anti-terrorism activities and recent review of CSIS' dataset regime.

2.2 Office of the Privacy Commissioner of Canada

ICLMG continues to engage with the Office of the Privacy Commissioner as part of our work on oversight and accountability. Since the last assembly:

• We participated in the OPC's quarterly civil society roundtable to discuss current privacy issues, including biometrics and Bill C-27

2.4 Review of national security legislation

Several pieces of national security legislation require mandatory review or renewal by Parliament. This year, three such pieces of legislation were supposed to be reviewed or renewed:

- National Security Act, 2017 (formerly Bill C-59) was meant to complete parliamentary review by June 2024
- National Security and Intelligence Committee of Parliamentarians (formerly Bill C-22) was also meant to be reviewed in 2023-24
- Section 83.3 of the Criminal Code which allows for preventative arrests if law enforcement suspect on reasonable grounds that it would prevent a terrorist activity, contains a sunset clause which expires in June 2024

ICLMG has continued to raise concerns about the lack of review with members of the Public Safety Committee. Our understanding is that no motion was passed to maintain s. 83.3 of the Criminal Code; its status remains uncertain.

3. Palestine and the right to dissent

The Israeli government, and its supporters, have attempted to justify their ongoing genocide against Gazans as "fighting terrorism," a view echoed by Canadian officials. ICLMG has continued to monitor the situation and take action. Since the last assembly, we have:

- Shared news, analysis, and joint letters calling for a ceasefire, an arms embargo, for Palestinian refugees to be let into Canada, and for Canadian support for the ICC's work with respect to Palestine/Israel
- We published a new statement to condemn one-year of genocide on October 7, 2024, as well as the smear campaigns, surveillance, harassment, fining and criminalizing of people, in Canada and abroad, expressing support for the rights of Palestinians: <u>https://iclmg.ca/one-year-of-genocide/</u>
- We have included concerns around the use of anti-terrorism as an excuse to stifle free expression and justify the Israeli military's violence in our critique of various pieces of new legislation and during speaking engagements.

4. Canada's terrorist entities list

Following the addition of Samidoun to Canada's terrorist entities list on October 15, 2024:

5. Canadians detained abroad, torture & redress

At least 17 Canadians, including 7 children, and three non-Canadian mothers remain indefinitely detained in camps and prisons in northeast Syria. On October 16, 2024, F.J., a Quebec mother of six who Canada refused to repatriate alongside her six children, was found dead in a Turkish deportation centre after having been acquitted of any criminal/terrorist allegations by a Turkish judge. As a result, we have:

6. Security certificates & inadmissibility

ICLMG has continued to work to eliminate security certificates, and defend the rights of those who are placed under one.

Since our last assembly this work has included:

- Updated and continued to push the Moe Harkat letter-writing campaign on June 26th, the United Nations International Day in Support of Victims of Torture
- Send another letter to the new Public Safety Minister for him to allow Moe to stay in Canada: <u>https://iclmg.ca/letter-harkat-2024/</u>

7. Anti-terrorism, national security and international bodies

7.1 Civil Society Coalition on Human Rights and Counterterrorism

The ICLMG continues to participate in the Civil Society Coalition on Human Rights and Counterterrorism. Since our last assembly this has included:

- Participation in quarterly coalition meetings to exchange information and strategize around impact of international counter-terrorism mechanisms on human rights in Canada and internationally
- Participation in quarterly working group meetings regarding impact of UN counter-terrorism activities on civil liberties and human rights

7.3 UN Counterterrorism Executive Directorate (CTED) Canada assessment

2023 year marked the second assessment of Canada's implementation of UN counterterrorism resolutions by CTED. Since then we have continued efforts for the public release of their report on Canada. To that end we have:

- Remained in contact with CTED regarding the status of the report;
- Followed up with Global Affairs Canada on the status of the report and urging its release.

8. ICLMG Twentieth Anniversary publication

We launched our 20th anniversary publication on September 11, 2024, the 23rd anniversary of the 9/11 attacks and the start of the so-called "War on Terror." We are grateful to all the contributors, translators, reviewers, and specifically Martine Éloy and Dominique Peschard from la Ligue des droits et libertés who helped so much during the editorial and publishing process.

- We sent out a press release announcing the launch and sent some advanced copies to key journalists
- We launched the publication with a webinar in English on Sept 11: <u>https://iclmg.ca/20-years-launch/</u>
- We had a second launch in person in Montreal, held in French organized by La Ligue des droits et libertés: <u>https://iclmg.ca/fr/lancement-montreal-20-ans/</u>
- We continue to share one article per week on our social media, and two texts per News Digest to increase visibility
- The publication is fully available online for free, but we are also sending physical copies to our top donors and all ICLMG members. The remainder are available for sale at https://iclmg.ca/20years/

9. Outreach, engagement and events

- Our social media accounts continue to increase in size and reach tens of thousands of people
- We have published 10 editions of the News Digest since the last assembly
- In June, we sent out our biannual "What we've been up to" email: <u>https://iclmg.ca/jan-june-2024/</u>
- We've been doing fundraising calls with every social media post related to the News Digest and the 20th anniversary publication
- Our campaign work continues to reach new audiences, and help with fundraising efforts. For example, we have received several donations following the statement calling for the abolition of the terrorist entities list which has also seen some of our largest social media engagements ever as well as several new email list subscribers
- We presented a guest lecture in a course on Privacy and Surveillance in the Masters of Public and International Affairs at York University
